









Finishing And Finishes

We apply a standard satin finish on our paint and stain products.

Please note that match stain orders will not be manufactured until a color strike of is returned to the dealer. Please ensure that Lanco receives both paint and stain matches with orders or very early after orders are received.

Please allow five to seven (5-7) working days for turnaround of strike of.

Paint/stain names and numbers of paint manufacturers only are not acceptable, but their color chart is acceptable if sent as a sample.

Lanco requires a minimum four (4) square inch sample for paints or solid colors and sixteen (16) square

inches for stains and translucent colors.

Important:

If color is critical, do not depend on Lanco standard paint or stain deck for exact duplication. If one of the chips on our standard deck is exactly the color required, submit the chip as a sample and add a match charge. Matching charges apply only to the standard satin finish. Please note the following variations;

1. Paint Matching

Add \$65.00 per match for standard satin finish (whites and pastels). Also add FedEx charge to return strike o (approx. \$25.00). Lanco will endeavor to return strike of with regular shipment whenever possible to limit the cost of FedEx Charges.

2. Stain Matching

Add \$85.00 per match for standard satin stain finish. Same return charges and conditions as Paint Matching (1.) above apply.

Note Carefully: With stains, only compatibility with tonal quality of sample can be assured because when deli with transparent finishes, there is no practical way that the physical characteristics of the sample can be duplicated. In addition, basswood absorbs stains significantly differently from other species of wood with its grains tending to have a higher level of absorbency for darker hues.

- 5. **High Gloss Finish:** (satin finish is standard) Add 15% (\$80.00 minimum).
